A West Africa Outreach Initiative: *Black Lives Matter Global Network Foundation Invests in the Diaspora*



ATLANTA, GA--- Black Lives Matter Board Members and nationally renowned leaders Cicley Gay and D'Zhane Parker and traveled to West Africa between May 24-June 2, 2025, to host a Borehole Commissioning in Ashaiman, and other humanitarian outreach and community engagement events

with the people of Ghana and Niger. The trip's overall focus centered around advancing impoverished communities, collaboration with the people, and inspired unity for all of West Africa. With an emphasis on social activism, Parker and Gay's travel was in deep partnership with West-

African led organizations, in AfriKicks and the Afro-Arab Group. AfriKicks, founded by Oumarou Id-rissa, focuses on collecting and donating shoes to the people of Africa. The Afro-Arab Group is a multifaceted company that operates the Afro-Arab Arena, a sports complex dedicated to the Spartans

Football Club in Ghana. The Afro-Arab Group hosted the charity soccer tournaments for this partnership at the Afro-Arab Arena. Black Lives Matter is delivering over 5,000 pairs of shoes, 40,000 toys, and \$150,000 worth of clothes—while building three clean water wells in

communities across Niger and Ghana, including one in Ashaiman. The trip also included high-level meetings with government officials, conferences and cultural outings. Activities ranged from the commissioning for the Borehole Project, hosting charity soccer tournaments, visiting or-

phanages, social engagement activities with village schools' children, and more. D'Zhane Parker and Cicley Gay are the two forces behind this partnership, and both bring upon extensive backgrounds in philanthropy, activism and direct service with them.

Poll: Only 38% of Americans Support Reparations for Black Americans

A new poll shows that most Americans do not support paying reparations to Black descendants of enslaved people in America. However, the same survey reveals that much higher percentages of respondents support reparations for Japanese Americans and Native Americans. According to YouGov, the poll was “professionally done” and is detailed and multifaceted. YouGov’s statement also says that the poll is timely because 2025 “marks 80 years since Japanese Americans were released from the prison camps in 1945” following the end of WWII. YouGov is releasing the poll’s results as members of the California Legislative Black Caucus (CLBC) continue to urge

their colleagues to support the 16 bills in the caucus’s “Road to Repair” reparations policy package. The bills, released at the beginning of this year, include legislation aimed at establishing a framework for paying reparations to the descendants of enslaved Black people, as well as other proposals that would improve equity and access to jobs, education, health care and more for Black Californians. “This bill package is about repairing centuries of economic damage and abuse that was inflicted on Black Californians,” said Sen. Akilah Weber Pierson, chair of the CLBC, when the package was released in February. Please visit www.wss-news.com to download the application.

"He Sure Fought Like Hell for Us": Californians Gather to Honor Trailblazer Nate Holden

LOS ANGELES —

Long before Martin Luther King Jr. Day was a national holiday, before California women could secure a home loan on their own, and long before South Los Angeles began to rise from the ashes of the 1992 unrest, Nathaniel "Nate" Holden, a towering figure in state politics, had already planted seeds for a more just and equal California.

On May 29, hundreds of Californians gathered at West Angeles Church of God in Christ to celebrate the life of this pioneering leader, who passed away May 7 at age 95.

More than a memorial, the service became a living testimony to a man whose legislative work and personal mentorship have shaped daily lives of people across the state -- from civil rights protections and cultural revitalization to grassroots

rity in the Inland Empire (IE) region. They have now until June 15 (when the Legislature has to pass their budget), and so the next couple of weeks are incredibly important.

“CalFood has allowed FARSB to offer more fresh, nutritious food to the families we serve, something that’s often out of reach for those living paycheck to paycheck. Without this support, the cost would have made it nearly impossible

for us to do this work at the same magnitude,” said Carolyn Fajardo, CEO of Feeding America Riverside | San Bernardino. “Just as importantly, the program uplifts California’s agricultural workers by helping ensure they earn a livable wage, which is a critical part of breaking the cycle of need,” she added.

CalFood is a vital anti-hunger program that millions of California families rely on to put food on

the table. It allows food banks to purchase California-grown foods, supporting local farmers and food producers, and ensuring communities have access to nutritious, culturally relevant options. But this critical program is at risk, with over \$50 million in annual funding set to expire at the end of June 2025.

Dr. Tickell has made this his signature event and wants to host it annually. This is the third year that the tea was held at the school.


The Master Gardeners and Preservers will provide educational content as the attendees learn about growing microgreens and taking home a container of seeds to grow.
